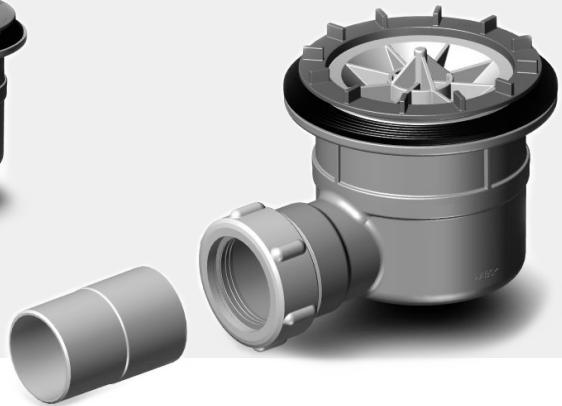

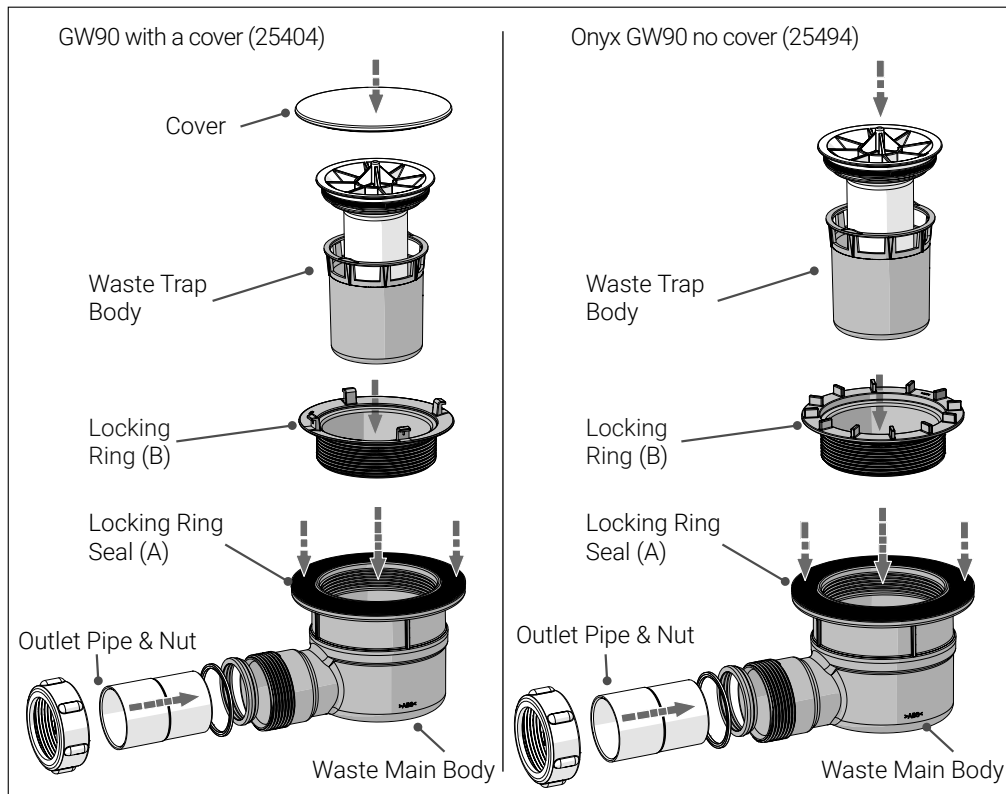

AKW wastes are designed for low maintenance and reliable operation. The trap valve is located inside the waste body should be checked as part of a planned maintenance programme.

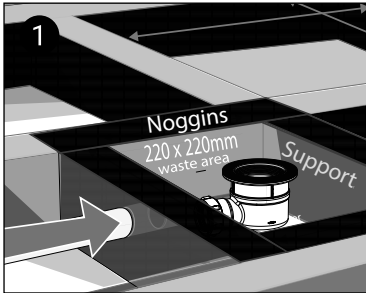
Keeping your wastes clean

This product should be cleaned periodically to remove any accumulation of hair or other waste material, using normal domestic bathroom cleaning materials. To clean the waste trap, first remove the cover to gain access.

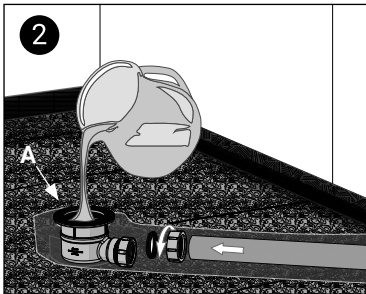
Disinfecting

Where disinfecting is necessary, standard procedures for disinfecting equipment should be used, taking due care and attention to the warning signs concerning possible effects of aggressive chemicals on plastics. After cleaning, always flush down with water then wipe thoroughly with a damp cloth to remove any cleaning material residues before drying. Do not use strong or concentrated acidic, alkaline or other cleaning materials as these may discolour or otherwise damage the product. Do not use abrasive cloths.

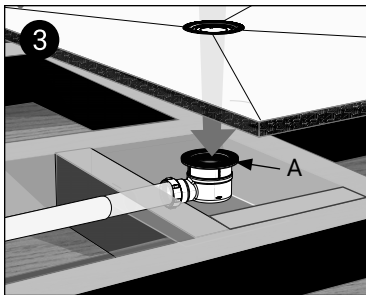
Suitable for wooden and solid floor installations. Use these in accordance with the shower tray instructions.



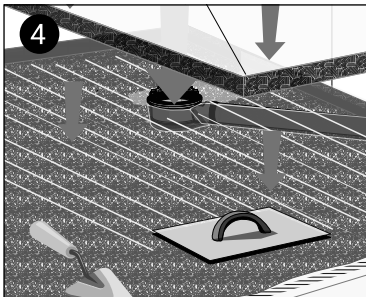
(1) As a "dry run", first place the tray into the desired location either into wooden or solid floors. Determine the position, the depth and the clearance required for the waste with at least a 1 in 40 fall from the waste to the outlet pipe. Ensure there is sufficient support around the waste area, see separate tray instructions.



(2) Before fitting the waste, place the nut onto the waste pipe outlet, followed by the backing ring and the seal. Insert waste pipe into the waste body and tighten the nut. Check that the pipe connection is correctly assembled, sealed and watertight by pouring some water through it. Ensure that the rubber clamping seal **(A)** is positioned into the recessed section on the top of the waste body before connecting to the tray.



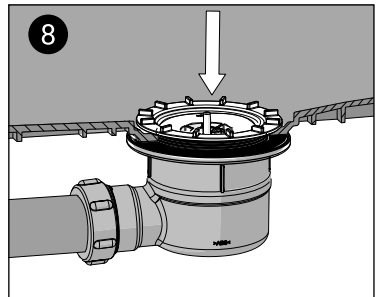
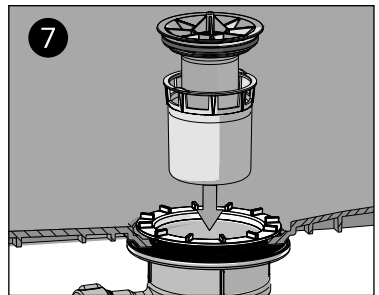
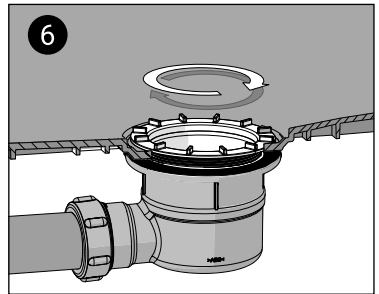
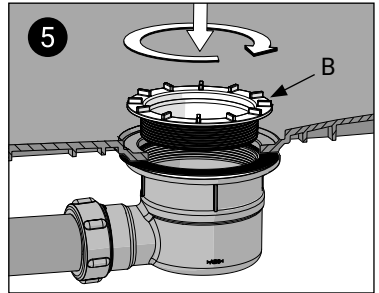
(3-4) Apply flexible adhesive to the tray and ensure that the tray is level. Lower the tray into position either into or onto wooden or concrete floors and then re-align with the waste body.



(5-6) Ensure the clamping ring **(B)** is screwed correctly to the waste body and is aligned with the tray. Do not over tighten but ensure a tight seal.

(7) Lower the waste trap body into waste main body and ensure a tight seal is achieved.

(8) Fit the cover ensuring correct location and it is flush with the tray. Protect the trap from debris during installation.
